TERMS & CONDITIONS

- (a) All the payments shall be made by Cheque / Draft / Pay order in favour of "HARE KRISHNA ORCHID".
- (b) I / We have applied for allotment of an Apartment with full knowledge and subject to all the laws / notifications and rules applicable to this project, which have also been explained by the company and understood by me / us.

- (f) The above mentioned basic price does not include EDC & IDC, IFMS, Electric connection & Meter Charges, Power Backup; Any other charges will be as specified in the Agreement.
- (g) That the allotment of Apartment is at the sole discretion of the company and the Company has the right to reject any offer / application without assigning any reason. In that case the Company will refund the Booking Amount along with interest at the rate of 8% p.a.
- (h) If there is any additional levy, rate taxes or charge of any kind attributable to the Apartment, as a consequence of any order of Government / Statutory or other Local Authority applicable, shall be payable by me / us on Pro-rata basis.
